LOCOTION: All races will be held in the vicinity of the Nations Farm, off Nations Road. The Nations Road may be reached by turning west off the Avon-Geneseo Rd. (Route 39). The physical address, 3330 Nations Rd., can be used for GPS and map software instructions (do not use as a mailing address). Signs will be posted.

## **General Conditions:**

- 1. All entries and scratches for sanctioned races (second and fifth races) are to be made through the NSA office (410) 392-0700. Entries close at 11:00 a.m. Monday, Oct. 3rd. Scratches close at 10:00 a.m., Wednesday, Oct. 5th.
- 2. All entries and scratches for unsanctioned races are to be made through the Race Secretary, Martha C. Wadsworth (585) 415-3369. Entries close Monday, Oct. 3rd. Scratches and declarations by 9:00 a.m. race day.
- 3. Any race that has not been filled by Monday, Oct. 3rd will be cancelled. Entered horses are permitted to re-enter, without penalty, any other race on the program for which they are eligible.
- 4. The Meet shall run under the rules of the NSA.
- 5. The Pony Races, Junior Race, and other unsanctioned races will be run under the rules of the Genesee Valley Hunt Race Committee.
- 6. The Committee reserves the right to change, modify, postpone or eliminate any scheduled race, and the decision of the Committee will be final.
- 7. The committee reserves the right, and without notice, to refuse any entry.
- 8. The Genesee Valley Hunt, Inc., its members or officers and/or agents of the owners of the land on which these events are held, individually or severally, will not be responsible for any property damage or personal injury to spectators, owners, riders or their agents, employees or friends, arising out of these events.
- 9. Waivers must be signed by owners/trainers and riders. The waiver is found with this entry form and also online at www.GVHRaces.com. Payment must be sent with entry or made online by following link at www.GVH Races.com
- 10. A horse may start in only one race.



- 11. The Genesee Valley Hunt and its officials take no cognizance of betting or wagering of any sort.
- 12. Riders will be required to attest that they have walked the course prior to post time.
- 13. Objections to the entry of any horse or rider must be lodged with the Racing Secretary before horses leave the paddock for the race.
- 14. No sex or other allowances may be claimed for any of these races, unless otherwise stated.
- 15. Supervised schooling over a portion of the course, footing permitting, may be allowed Thursday, Oct. 6th, 4:00 to 5:00 p.m. Call secretary at 585-415-3369 after 10:00 am. Thursday to confirm.
- 16. Equipment and condition of horses must be approved by the Paddock Judge on race day. A flat saddle is required for all races, except for entries in the Stockhorse Sprint.
- 17. For all races safety helmet with harness must be worn. For jumping races, safety vests are required.
- 18. Turnout awards will be given for the best "turned out" horse or pony in the three Junior Races, the Adult Pace Race, the Heavy Horse race and Polo Pony Race. There will be a \$100.00 award, to the groom of the best "turned out" horse in races 1, 2, 3, 5, 7 and 8.
- 19. FOR CROSS ENTERING pay entry fee for each race entered, PLUS an additional \$10.00.

**20.** *REMINDER: All riders in unsanctioned races must submit medical insurance information with entry.*

Flat race about one guarter mile on the turf. For ponies 13.2 and under, 4-year olds and up. For riders who have not reached their 14th birthday. Catch weights. Trophy to owner of winner. Eight ribbons. Entry Fee: \$25.00. Post Entry Fee: \$35.00. Approximate post time 11:00 am

### Large Pony Race

Flat race about one half mile on the turf. For ponies not exceeding 14.2, 4-year olds and up. For riders who have not reached their 16th birthday. Catch weights. Trophy to owner of winner. Eight ribbons. Entry Fee: \$25.00. Post Entry Fee: \$35.00. Approximate post time 11:15 am

## Leif Heen Memorial Jr. Race

Race about a mile on the turf For horses and ponies. For riders not to have reached their 18th birthday. Catch weights. Trophy to owner of winner. Entry Fee: \$35.00. Post Entry Fee: \$45.00. Approximate post time 11:30 am

#### Adult Pace Race

#### **Purse:** \$100

Entries (the field) to follow a pace horse over the course of approx. 1 3/4 miles over timber. At the designated signal, riders race to finish. For riders age 13 years or older who are approved by the stewards. Hunt attire. Trophy to owner of winner. Entry Fee: \$40.00 Post Entry Fee: \$50.00.

#### **Heavy Horse Race**

Flat race about one half mile on the turf. For draft or 1/2 draft. Minimum weight165+ lbs., without lead; overweights allowed. Riders to be 16 years or older who are approved by the stewards. Entry fee: \$35.00. post entry fee: \$45.00. Approximate post time: 2:10 pm

For riders (players)13 years and older. Riders must bring own mallet and ride in polo attire and helmet. Trophy to owner of winner. Entry Fee: \$20.00. Post Entry Fee: \$30.00.

## COVENANT NOT TO SUE, RELEASE, WAIVER OF CLAIMS, INDEMNITY AND INSURANCE AGREEMENT

(An exculpatory agreement and permanent bar to asserting any claims which exists or may occur.)

This agreement is entered into as a condition of and a part of the consideration for the Masters, Governors and Members of the Genesee Valley Hunt. Inc. and the same individually, and the Genesee Valley Hunt, Inc. (GVH) and the property owners and their tenants (landholders) agreeing to allow me (us) to ride with the GVH Race Meet over certain designated property of the landholders, or any other involvement with horses, or any activities incidental, attendant, or related to the foregoing:

I (we) understand and acknowledge that any involvement with horses can be hazardous and that racing is an athletic event which involves numerous risks of injury and that horses are often unpredictable and difficult to control.

I (we) voluntarily and expressly assume all risks and dangers of such involvement.

I (we) (my heirs) agree not to sue GVH, or the landholder(s) of property where any of the activities mentioned above may take place, and I (we) (my heirs) waive and release any and all claims arising out of such activities or the use of such property, including but not limited to any claims alleging negligence, breach of contract, strict liability, or otherwise, of GVH, or any such landholder(s). This covenant not to sue, waiver and release includes, but is not limited to, bodily injury, death, property damage, loss, contribution, indemnity or any other claims which I (we) (my heirs) may ever have against GVH, their agents or employees, or any landholder(s).

I (we) (my heirs) also agree to defend, indemnify and hold harmless GVH and any landholder(s) involved from any expenses, damages or judgements, including any legal expense, reasonable attorneys fees, claims for contribution or indemnification, resulting from claims by third parties arising out of my (our) activities mentioned above, or the use of any property in relation to any such of my (our) activities and if applicable, the claims by my (our) children listed below before or at majority.

I (we) also acknowledge and agree that I (we) have, or it is our responsibility to obtain and keep in force, sufficient insurance coverage (including but not limited to liability. health and life) to protect me (us) from any expense, liability claims, or damages mentioned or included in this agreement and that whether or not I (we) obtain such insurance and whether or not such insurance is sufficient, the provisions above shall be fully effective and enforceable and I (we) will be bound and liable thereunder.
